Geek Squad 90-day Limited Warranty

Geek Squad warrants to you that this refurbished "Product" shall be free of defects in material and workmanship for a period of 90 days from the date of purchase ("Warranty Period"). This warranty is valid only in the United States and Puerto Rico on Product purchased from BestBuy.com®.

This limited warranty does not cover:

- Cosmetic damage
- Defects caused by misuse, abuse, accident, negligence or acts of God
- Products that have been modified or whose serial number or warranty/refurbished sticker has been altered or removed
- Products that have been improperly maintained or that anyone other than a service provider authorized by Best Buy® or Geek Squad has attempted to repair
- Products used commercially

Obtaining warranty service:

Before the Warranty Period expires, either bring the Product to a Best Buy store or call 1-800-GEEK SQUAD (1-800-433-5778) for special instructions.
